Mayor Corino called the Public Hearing regarding the Village of Shortsville Budget 2025-2026 order at 6:00 P.M.

The Pledge of Allegiance was recited.

The tentative figures in the proposed Village Budget for the 2025-2026 fiscal year are as follows: General Appropriations \$1,684,492 Water Appropriations \$229,952 Sewer Appropriations \$212,020

The Village of Shortsville's tax rate will be \$8.37/1,000. The sewer rate, water rate and overage fees will remain the same: The water rates for inside users are \$30/1,000 cubic feet and the overage is \$6 per each 100 cubic feet. The water rates for outside users are \$60/1,000 cubic feet and the overage is \$12 per each 100 cubic feet. The sewer rates for inside users are \$70/2,000 cubic feet and the overage is \$7 per each 200 cubic feet. The sewer rates for outside users are \$105/2,000 cubic feet and the overage is \$10.50 per each 200 cubic feet. The Meter Maintenance Fee will be replaced with an Operation & Maintenance Fee in the amount of \$20 per quarter. New water service and new sewer service tap in fees will be \$1,500.

Mayor Corino asked for any public comment: Brad Hixson asked a question regarding the increased assessments of houses throughout the village.

Mayor Corino asked two more times for public comment. There was none.

The Public Hearing was closed upon motion of Trustee Langdon, seconded by Trustee Trimm at 6:05 P.M.

Mayor Corino opened the Village Board Meeting at 6:06 P.M.

The minutes of the previous meeting were prepared beforehand by the Village Clerk-Treasurer and on motion by Trustee Langdon, seconded by Trustee Trimm, voted and carried unanimously to accept as prepared and placed on file. Motion was made by Trustee Trimm, seconded by Trustee Langdon, voted and carried unanimously to accept the March 2025 Trial Balance (Edmunds), Bank Statement (CNB), Revenue/Expenditure Analysis (Edmunds).

Motion was made by Trustee Trimm, seconded by Trustee Langdon, voted and carried unanimously to audit and approve the following bills for payment and all budget transfers:

Board Items:

Kyle Jacksno gave updates for the DPW: large drainage project at Budd Park was successful. Some area cannot be driven over so Kyle will mark it off with cones for CHC carnival, DPW crew will continue to finish ground work, pot holes, cleaning along outlet. Hynes Concrete will be taking all of the dumped concrete that is at the pump house, the water tank inspection is scheduled for Friday, April 11, holes in dark park are being worked on, baseball field raked, prepped flower beds, WWD banners are up. Kyle asked the board where the ice rink liner should be moved to and the decision was into the Fire Hall.

Brad Hixson stated that he appreciates the reports from the DPW and asks that at the time he is not at the meeting, if he could provide the board with a report so they can read it off. Also, Mr. Hixson would like to hear what the Trustees have been working on.

Bob Johnston, 1755 Pioneer Road, would like to tie into the village sewer. He is asking for permission from the village. Rich Vienna was also present and spoke on the topic stating that Mr. Johnson is aware that he will be responsible for maintaining the line.
